## MINUTES OF THE TOLEDO COUNCIL REGULAR MEETING HELD AT THE REINIG CENTER, 1007 S. PROSPECT DRIVE, TOLEDO IA STARTING AT 5:00 P.M.

The meeting was called to order at 5:00 p.m. with Mayor Sokol present and presiding. Answering roll call for the City of Toledo were Vesely, Pansegrau, Boll, Goodhart, and Cook. Others present were Marquess, Jordan, Chief Quigley, N. Wunn, G. Johnson, M. Davis, and K. Campbell. (Note: Cook left at 5:30 p.m. citing medical)

Mayor Sokol requested a motion to approve the consent agenda. Cook motioned to approve, seconded by Pansegrau. All present voiced ayes, no nays, motion carried. The approved consent agenda consisted of the following items: minutes from the 6/24/2024 regular council meeting and 5/28/2024 Library board minutes. Pansegrau motioned to approve STC Rec, Chelsea Ahrens to replace the Toledo Heights scoreboard utilizing a Mansfield grant that expenses and revenues will be a pass through for the city.

Vesely motioned to approve lien placement on 200 Business Hwy 30 W for mowing in the amount of \$250.00, seconded by Cook. All present voiced ayes, no nays, motion carried.

Vesely motioned to accept resignation of Officer Nick Ryan, effective July 11, 2024 and the request to advertise the position, seconded by Cook. All present voiced ayes, no nays, motion carried. It was noted that the resignation letter was not provided for the council and would be attached with these minutes.

Pansegrau motioned to approve use of the Toledo Heights Park on August 22, 2024 for the circus, seconded by Vesely. All present voiced ayes, no nays, motion carried.

Mayor Sokol moved to department, council reports, and public comments. Hearing no further comments, Vesely motioned to close the public meeting and move into closed session pursuant to Iowa Code 21.5(1)(c), seconded by Goodhart. Roll call vote, all present voiced ayes, no nays, meeting moved to closed session at 6:00 p.m.

Vesely motioned to move back into open session at 6:20 p.m., seconded by Pansegrau. Roll call vote, all present voiced ayes, no nays, meeting moved to open session. No action was taken on the closed session. Having no further comments, Vesely motioned to adjourn at 6:24 p.m., seconded by Goodhart, All present voiced ayes, no nays, meeting adjourned.
